

**TERMS AND CONDITIONS**

1. Intending Tenderers who are willing to purchase the Tender forms will have to submit an applicant to the undersigned before the specified date & time.
2. The rate should be quoted both in figure and words clearly on percentage basis. The rate should be inclusive of all taxes and incidental charge..

3. An earnest money of specified amount should be deposited along with the Tender form in the form of Bank Draft in favour of the undersigned. Bank token in place of draft and N.S.C will not be entertained. Balance 8% security money will be deducted from the bill to constitute 10% security money. Tender submitted without earnest money will be treated as informal. The security money will be released as per norms.
4. The payment will be made after successful completion of work subject to availability of fund. No payment of extra work beyond the restricted amount will be made till the fund is received from the authority.
5. The sealed tender will be dropped in the tender box keep in the office chamber of the under signed up to the specified date & time will be opened by the under signed by the same date at 2.30 P.M. in presence of the participating renderer who desire to remain present at this time.
6. Acceptance of lowest renderer is not obligatory & the under signed reserves the right to reject or accept any or all of the Tenders received at this description without assigning any reason what so ever at any stage. It also to be noted that if rate offered by any tenderer 15% below of the tender valu , he must enclose a rate analysis with his papers at the time of dropping. Otherwise his paper will not be taken into account at the time of preparing of comparative statement & will be declared informal outright.
7. Measurement for supply of materials shall be taken in stacks, where applicable as soon as possible after the stacks are made. Deduction for sink age and/or shrinkage will be as per Govt. rules.
8. All terms & conditions will be followed by PWD rules & norms.
9. The successful tenderers must complete the work within the time specified for completion. No extension of time will be entertained, except special case. If any tenderer fails to complete the work with the stipulated time the work issued in his favour will be cancelled without assigning any reson therefore. The undersigned may also proceed to get the balance work completed by any other means including through others contractors. The excess expenditure, if any, due to such a step would be recoverable from the unpaid bill/ security deposit of the tenderer.

11. No Tender paper will be accepted by post.


