An earnest money of specified amount should be deposited along with the Tender form in the form of Bank Draft in favour of the undersigned. Bank token in place of draft and N.S.C will not be entertained. Balance 8% security money will be deducted from the bill to constitute 10% security money. Tender submitted without earnest money will be treated as informal. The security money will be released as per norms.
- 3. The payment will be made after successful completion of work subject to availability of fund. No payment of extra work beyond the restricted amount will be made till the fund is received from the
- 4. The sealed tender will be dropped in the tender box keep in the office chamber of the under signed up to the specified date & time will be opened by the under signed by the same date at 2.30 P.M. in presence of the participating tenderer who desire to remain present at this time.

Acceptance of lowest tenderer is not obligatory & the under signed reserves the right to reject or accept any or all of the Tenders received at this description without assigning any reason what so ever at any stage. It also to be noted that if rate offered by any tenderer 15% below of the tender valu , he must enclose a rate analysis with his papers at the time of dropping.
